Data Protection

The protection of your personal data is particularly important to us. In this data protection information we inform you about the most important aspects of data processing in the context of member administration. Comprehensive information on how the GÖD/ÖGB handles your personal data can be found at www.oegb.at/datenschutz.

The ÖGB is responsible for the processing of your data. We process the data provided by you with a high degree of confidentiality, only for the purposes of managing the union's membership and for the duration of your membership or as long as there may still be claims from membership. The legal basis for data processing is your membership in the GÖD/ÖGB; if you have agreed to the company deduction, your consent to the processing of the additional data required for this.

The data processing is carried out by the GÖD or the ÖGB itself or by contract processors commissioned and controlled by them. Any other transfer of the data to third parties does not take place or only with your express consent. Data processing takes place exclusively within the EU.

You have the right to information, correction, deletion and restriction of processing in relation to the GÖD/ÖGB with regard to the processing of your personal data. You can lodge a complaint at any time with the Austrian data protection authority (www.dsb.gv.at) as the supervisory body against any processing of your data that you consider inadmissible.

The monthly membership fee is 1% of the gross monthly salary, but no more than 1% of the reference amount according to Section 3 (4) GehG.

The membership fee is tax deductible, in the case of a deduction by the employer, this becomes effective immediately. A reduced fixed fee applies to:

• Pupils, apprentices, administrative assistants, nursing students and military service in training (PiAD): € 1.10 per month.

• Students, unemployed, extraordinary parental leave and unpaid sick leave: € 1.80 per month.
